



Driving under the influence is illegal. Aside from concerns for the personal safety of yourself and others, there are severe legal penalties and economic consequences if convicted. It is important to know that the DUI criminal charge is prosecuted in court and the driver's license sanctions are administered by the Secretary of State's Office. If convicted of DUI in Illinois, the following penalties apply:

Legal fees	Uncontested plea and hardship driving permit.	\$5,000
Court Ordered Fines	Fine up to \$2,500. Law Enforcement Equipment Fund:-\$500. Lab Fee: \$150 Reimbursement to law enforcement, towing and storage fees - \$500. Trauma center fund - \$100.	\$3,750
BAIID COST	Approx. \$110/month during the suspension/revocation period, plus \$100 installation fee.	\$760
Income Loss	Loss of 4 weeks income due to jail or community service, court appearances, evaluations and remedial education classes. (Loss based on average yearly income of \$40,000.)	\$4,000
Rehabilitation	Evaluation at \$150 and basic remedial substance abuse class at \$250.	\$400
Driver's License Reinstatement	\$500 plus \$10 for a new license; \$500 for multiple DUI offenders, \$50 formal hearing fee.	\$560

Medical treatment for a crash involving injuries or fatalities	\$100,000+
Compensatory damages awarded to crash survivors	\$10,000+
In-patient substance abuse programs	\$3,500+
Legal fees for jury trials and civil proceedings	\$10,000+

BAIID COST	Approx. \$110/month during the suspension/revocation period, plus \$100 installation fee.	\$760
Income Loss	Loss of 4 weeks income due to jail or community service, court appearances, evaluations and remedial education classes. (Loss based on average yearly income of \$40,000.)	\$4,000
Rehabilitation	Evaluation at \$150 and basic remedial substance abuse class at \$250.	\$400
Driver's License Reinstatement	\$500 plus \$10 for a new license; \$500 for multiple DUI offenders, \$50 formal hearing fee.	\$560
